We just finished finalizing the Agency gift giving distribution plan at our Board meeting this past week, for our current year. The needs always exceeds our funding amount ability but I am very pleased to announce that our amount, of total funding gifts, is \$62,100 which will go to support the "at risk" kids here in the Savannah community. ## Information on a Real Tax Break

If you missed the last couple of our Thursday meetings, you did not have the opportunity to receive a copy of: <u>"The State of Georgia GOAL Scholarship"</u> contribution form. This is a great way to help provide for a child's care and education at Bethesda Home for Boys. The Georgia State GOAL Scholarship program provides a way for Georgia Taxpayers to get a 100% state tax rebate for a contribution to Bethesda. You can also include the contribution on your Federal tax return. This is a unique opportunity to help disadvantaged kids at no cost and little effort.

You may claim \$1,000 for individual filers, \$2,500 for joint filers and for "C" corporations up to 75% of the total Georgia tax liability.

To participate, fill out Georgia tax form IT-QEE-TPI (can be downloaded from the Get Involved section of the "Bethesdaforboys.org" web site. This site also provides a step-bystep guide to fill out the form. These forms will also be on the breakfast meeting tables over the next several weeks. We suggest you complete this brief form along with a check and send to:

Or you may n give to Gary Hughes or Bill Wright for processing. You will receive a receipt within 10 days from the State of GA. You will file this receipt with you tax return and receive a full credit for the amount you submitted.

This really is an easy way to "re-direct" a portion of your Georgia taxes and make a big difference to the young men of Bethesda.

# **Johnson Square**

Johnson Square was the first of Savannah's squares and remains the largest of the twenty four. It was named for Robert Johnson, colonial governor of South Carolina and a friend of General Oglethorpe.<sup>[7][8]</sup> Interred in the square is Revolutionary War hero General Nathanael Greene, the namesake of nearby Greene Square. Greene died in 1786 and was buried in Savannah's Colonial Park Cemetery. His son, George Washington Greene, was buried beside him after drowning in the Savannah River in 1793. Following vandalism of the cemetery by occupying Union forces during the Civil War the location of Greene's burial was lost. After the remains were re-identified Greene and his son were moved to Johnson Square. An obelisk in the centre of the square now serves as a memorial to Gen. Greene.
