

<u>Call to Order and Roll Call</u>—Mr. Wright began the meeting at 8:00 A.M., with Messrs. Bocard, Brewer, Hietbrink, Zugel, and Sharp absent.

<u>President Elect's Report</u>—Mr. Wright had kind remarks about the Concert on the Green held on May 3rd, and congratulated Dick Nelson and his Committee. The Committee was composed of new members except Advisor Bob Caswell. The Committee prepared a reprise of the event, and noted an improved sound system, slow service for the Patrons food, and tough beef. The Mercer theme worked well, and the idea should be continued.

Net income of \$11,243 exceeded last year, \$9575, and budget, \$9000.

Mr. Wright said Reland B. Westgate, who died recently, helped to establish The Golden K in 1987. He was Past President of the Savannah Club, and Lt. Governor of our Division. Martin Otto confirmed Reland's participation in the founding of our Club. On a motion by Mr. McDonald and a second by Mr. Frame, a Dollars for Doers contribution of \$300 for the Children's Miracle Network was approved by voice vote, to commemorate Mr. Westgate's role in the establishment of Kiwanis on Skidaway.

Mr. Wright said Mr. Bocard suggested Thursday, September 24th, as the date for a dinner to recognize the new and retiring officers and directors. The Directors also proposed the recognition of new members, and Chairs of the major fund raising events. It was hoped that a fun evening, with a good speaker could be arranged.

Mr. Wright asked for Board approval to ask Ron Weber, incoming Secretary, to attend the District Convention in Brasstown, since Mr. Wright cannot attend. On a motion by Mr. Forssell, and a second by Mr. Fox, Mr. Weber will be asked to attend as one of the Club's delegates. The motion was approved by voice vote.

<u>Secretary's Report</u>—A motion to approve the minutes of the Board meeting of April 13th, and the Official Monthly Report of April, was offered by Mr. Overton, and seconded by Mr. Fox. Mr. Forssell said his attendance was confirmed by several, but he was not listed as present. After this change, the motion was approved.

Mr. Forssell said the Official Monthly Report computer program would not accept his full write up of the Early Childhood Education Seminar. Only 516 words were allowed to explain member Tom Clark's instigation of this successful event.

On a motion by Mr. Overton and a second by Mr. Beurle, the following applicant was approved, on a voice vote for membership in the Club:

Special Report on Sponsors—Mr. Heeder joined the meeting to update the Board on the Sponsor's Campaign. His unofficial estimate for this year is \$27750 versus \$29000 raised last year. Fifteen new Sponsors were secured so far, with one existing Sponsor upgrade, and one downgrade. Discussion was had with good input, with emphasis on Sponsor recognition. It was decided to make the list of Sponsors available in every venue possible and include an enumeration in the Kiwanigram each month.

Treasurer's Report—Mr. Ahrens reported a drop in cash in the Service account due to expenses for the Concert, which will be offset when receipts are entered in the May period. He said the Administrative account for 50-50 is ahead of budget, and the overall account will be positive at year end. A question arose about how Kroger's contribution to the Pancake Breakfast was handled. The Funds Flow statement reflected poster cost of \$1500, Pancake expenses of \$3700 and two Dollars for Doers payments. Mr. Ahrens and Mr. Frame will consult with Mr. Weber to clear the Kroger question.

V.P. Service's Report—Mr. McDonald said 19 funded agencies received a letter requesting information in connection with the Club's contribution. Six agencies have responded. He will have a preliminary schedule of suggested contributions for the June Board meeting.

V.P. Fund Raising's Report—Mr. Frame will have additional meetings with his committee to review plans for next year's Concert, and new or changed fund raising events. Two ideas for new events have been floated by the committee to wit:

A golf marathon event

A road race event.

More on this at the June meeting of the Board.

<u>V.P. Marketing's Report</u>—Mrs. Emery said two fund raising events are planned to raise funds for the Symphonic Choir:

Benefit concert at Armstrong on May 14th

Jacob Friedman, a near child prodigy pianist, at the Jewish Temple on May 31st at 4:00 P.M.

Old Business—Mr. Overton junked about one half of the storage locker's contents to make room for the 150 folding chairs donated to the Club. The \$600 annual cost of the locker is being raised to \$720. He will explore renting a container, which might be placed in the Landing's Association outside storage, to reduce or eliminate the charge.

New Business—Mr. Fox turned over \$310 to Mr. Ahrens, the proceeds of the sale of baseball tickets for the Sand Gnats game on May 6th (Kiwanis Night). The Savannah Kiwanis bought 400 tickets, and received a discount of \$3.00 per ticket. Our tickets sold by Mr. Fox, had the same discount.

Adjournment—Mr. Wright closed the meeting a 10:00 A. M., well short of the record.

THE HARLEM MIRACLE, could be the American Education Miracle.

(see David Brooks' OP-ED article in NY Times of May 8, 2009)

The Olympic miracle win by the US Hockey team in 1980 gave us a tremendous sense of pride and accomplishment, and what has been happening in education to equalize between Blacks and Whites the results of education in Harlem, is just as miraculous. David Brooks quotes the meticulous Harvard economist, Roland Fryer, as saying that the results from the Harlem Children's Zone (HCZ) have "changed my life as a scientist".

Geoffrey Canada, as a guest of Mayor Otis Johnson, was in Savannah April 30th to explain his HCZ results to interested citizenry organized by the Youth Futures Authority. He said there will be federal funds for duplicating the Zone in 20 American cities, if a designated city is willing to do "whatever it takes" to put in the effort. Our public school system is doing a fine job trying to create accountability and order in all of its schools, but it needs a boost from better informed cooperative parents who could be doing more with their babies under the age of two years old. The creation of "Baby College", described in Paul Tough's book about the HCZ, "Whatever It Takes", would provide information to greatly improve the safety, self esteem and appreciation of language long before Pre-K is entered. This program could then blend into our existing "Parent University". We already have the results of the brief success achieved at the Garrison Elementary School in 2001-2004 with intensified parental participation.

Parenting Education could be afforded at each and every child care site and coordinated by an Area-Wide Early Childhood Education Department with its own Education Czar to phase children into the public school system at the appropriate time. There are a lot of efforts being made in Savannah, but major help should be afforded for the pregnant women and continued all along the way until this resulting child enters college if he or she so desires. The cost to society will be vastly overshadowed by the benefits. Just ask the Harvard economist.
