Pancake Breakfast: A Roaring Success

The 21st Annual Kiwanis Pancake Breakfast was a roaring success, with 1,000 breakfasts served.

The event was held at the Skidaway Island Presbyterian Church on February 8, and according to Christine Swanson, co-chair of the event along with Cecilia Russo and Matt Spencer, it was one of the largest turnouts ever.

"We served up a quarter of a ton of bacon and sausage, went through 220 pounds of pancake mix and 104 quarts of orange juice, and I can't even begin to tell you how much coffee," she said.

Swanson said this year's breakfast included some new additions, such as an appearance by Magic Mark and a coloring contest sponsored by Merrill Lynch. Perhaps it was these new additions that drew a larger-than-normal crowd or simply the giving spirit of Landings residents and other area attendees.

"It is important to note that approximately 30 agencies in the Chatham County area will benefit from 100 percent of the proceeds of this breakfast," Swanson said. "Our primary focus is helping disadvantaged children in this area. In the 26 years the Skidaway Chapter of Kiwanis has been in existence, we are proud to have raised \$1.3 million, all of which has gone to local charities."

Swanson said this year's breakfast could not have been the success it was had it not been for a number of factors, including the participation of more than 80 Skidaway Chapter Kiwanians who volunteered their time to organize, publicize, and work the event.

"We say thank you to everyone who helped to make our 21st Annual Kiwanis Pancake Breakfast possible," she said. "We are grateful to all of our members and community supporters. I also extend a special thank you to Youth Challenge. This extraordinary group of young men and women did an amazing job helping us. They showed up before 6 a.m. that morning and stayed through cleanup helping to serve and clear tables. This event would not have been the success it was without them."

Although the Pancake Breakfast now is a pleasant memory, the group already is looking ahead to the next event. "Our Kiwanis Club has three major fund raisers each year," Swanson said. "Our next big event is Concert on the Green on May 4. That event is held on The Landings Association's Athletic Field. I encourage people to mark their calendars now and make plans to attend. Additionally, I urge everyone to make plans to attend next year's pancake breakfast as we already are planning for more exciting additions that you don't want to miss."

Each year one club in each Division is asked to put up a candidate for the position of Lt. Governor of that Division for the following year. The candidate must be a past club officer (preferably president) or have previously held another office in the District. The candidate is presented at a Division Rally sometime before the end of the current year where all clubs in the Division affirm him or her as their incoming Lt. Governor. When the new Kiwanis year begins on October 1, the new Lt. Governor will provide oversight and guidance to all clubs in the Division and serve on the Georgia District Board of Directors.

Earlier this year, President Melissa Emery was informed that it was the Kiwanis Club of Skidaway's "turn" to provide a candidate for 2014–2015. After a thorough search of the qualified candidates, and offers of this opportunity to each of them, we concluded that Erv Hietbrink would be our man. Erv's previous experience as a Distinguished two-term Lt. Governor led us to conclude that we will be in good hands and that our club will be well represented.

In addition, Erv has agreed to participate in a special 3-year Kiwanis International Club & Membership Growth initiative. As such, he will serve on a District task force, led by former District Governor Dewey Smith, charged with growing the Kiwanis organization across Georgia.




